GENERAL CONDITIONS

WELCOME

Out of respect for campers' peace and quite, to provide them with a secure campsite, access to our campsite is reserved for those who are holders of our badge handed out in exchange for a safety deposit of 20 euros. The reception desk is opening from 9 p.m. to 12 p.m. and from 15 p.m. to 19 p.m.

PRICES

Sport equipment access and playground access are included in our prices. It is compulsory to wear a bathing suit in the swimming pool area. Underclothes are strictly prohibited. The swimming pool (16 x 8m + paddling pool) is open as of middle of May, depending on the weather.

PETS :

Dogs and cats are admitted in accordance with the current laws. You must present an up-to-date vaccination certificate. They must be in leash.

RESERVATION

Advised in July and August for campsite, obligatory during the opening of campsite for hiring. Any rent is personal and cannot be ceded or sub-leased. The number of people occupying the residence of tourism or the campsite cannot exceed the capacity envisaged.

PITCH RESERVATION

The rent becomes effective only after reception of the rent contract signed and accompanied by a part-payment of 30% (+ eventually insurance) Not reservation for a period inferior at 6 days.

At reception of deposit and contract, we will come in you a confirmation of reservation. It must be presented them at the reception the day of your arrival.

Arrival : Camping sites free at midday. No entry after 8 p.m. for peace of camper.

The most you can put on one pitch is one vehicle and one tent or caravan. Any additional installation will be charged.

Any additional vehicle will be park on external car park.

Any modification during the stay (number of persons) should be mentioned at the reception desk.

The total cost of your stay is payable at your arrival.

Départure : before midday

HIRING RESERVATION

Reservations are considered to be confirmed upon receipt of a 30% instalment of the total amount of your stay.

At reception of deposit and contract, we will come in you a confirmation of reservation. It must be presented them at the reception desk the day of your arrival. The balance must be settled 1 month prior to your arrival.

One vehicle must be park on campsite. Any additional vehicle will be park on external car park.

Arrival : Hirings are available after 3 p.m. No arrivals after 8 p.m. For the hire-objects, the client will have to pay a deposit (150 €) which will be return on the day of your departure after the inventory.

In all rentals listed below: You will find everything you need for cooking. Pillows and blankets are provided.

To avoid any dispute, the tenant will want to control well and point out to the Reception Office any anomaly in the 24h after his arrival.

Departure : Before 10 p.m. The accommodation must be clean at your departure.

If this is not the case, 50€ shall be retained from the deposit to get the hiring "ready for hire".

LATE ARRIVALS AND EARLY DEPARTURES

No reductions or refunds will be made for late arrivals or early departures.

INSURANCE

The camper has to insure himself. The camp-site declines any responsibility in case of theft, fire, bad weather etc... and in the event of concerning incident responsibility for the camper.

CANCELLATION

A cancellation insurance must be take out insurance Campez couvert*. www.campingfontisson.com/en/telechargement-camping-fontisson-avignon-vauclose.html Any cancellation of reservation will have to be done by registered letter. In case of cancellation, it stay to pay for indemnity of breach of contract :

- 25% of your total's visit if you cancel 1 month before the arrival date.

- the visit's totality if you cancel less 1 month before the arrival date.

VARIOUS The camping has the right to eject any offender at Camping Fontisson's rule. The Avignon's Tribunal is competent in case of litigation.

* The campsite offers you optional Cancellation and Interruption insurance in your rental contract. Our partner Gritchen Affinity will refund all or part of the stay only to customers that have purchased Campez Couvert insurance. In case of cancellation, please notify the campsite of your cancellation as soon as an event occurs that prevents your departure, by letter or by email.
